**PURPOSES OF SPECIFIC PROCESSING**

The collection of data (common data) that are entered and stored on this web page are aimed to manage:

**RETENTION PERIOD OF COLLECTED DATA**

Personal Data, collected for the abovementioned purposes, will be stored for the time necessary to fulfil related activities; afterwards data will be destroyed (right to be forgotten) or made in an anonymous form if necessary for statistical or historicizing reasons (pseudonymisation).

**RIGHTS OF DATA SUBJECTS**
